Adult Day Services offers three programs that help adults with autism fulfill their potential and enjoy fuller daily lives. The first program, the Supported Employment program, assists adults with autism in finding and enjoying successful employment. The second program, Community Based Services, offers adults with autism many opportunities to participate in community life such as shopping, dining out, banking, and recreational events. The third program, EXCELL, serves those adults with autism whose severely challenging behaviors prohibit them from receiving services elsewhere. The number of individuals served by this program during the year was 146.

Statewide Services provide services to families in out-state Missouri and rural areas which might be unable to access facility-based services. The services include assessments, parent training, family support, community inclusion, and music therapy. The number of individuals served by this program during the year was 2,410.
