THE CATHOLIC ARCHDIOCESE OF ST. LOUIS DIRECTORY AS A MEMBERED SCHOOL. THE
"FOUNDING FATHERS AND ADMINISTRATORS" EMPLOYED STAFF AND ACCEPTED STUDENTS
OF ALL ETHNICITIES AND RACES; HOWEVER, THEY NEVER "OFFICIALLY" KEPT
RECORDS NOR OFFICIALLY STATED THEIR "UNOFFICAL" NON-DISCRIMINATORY POLICY
