Education Program Sunflower House partners with more than 185 Johnson and Wyandotte County schools and preschools to provide personal safety and prevention programs More than 25,000 children, parents, and professionals are educated about child abuse each year Through our flagship program P S It's My Body!, including P S Happy Bear Play, our educators teach children to recognize, resist and report child abuse to a trusted adult We also provide mandated reporter training to more than 1,600 professionals legally mandated to report suspicions of child abuse and neglect Mandated reporter training instructs education professionals to recognize the signs of maltreatment and to understand the reporting processes and laws Other educational programs offered for the community include Keeping Kids Safe Online, teaching parents and young people about protecting from the risks associated with Internet and cell phone usage, Abusive Head Trauma, and Stewards of Children

Child Assessment Program Sunflower House's Child Assessment Program is focused on ensuring that victims of child abuse and their families receive their best chance at justice and healing. The program works toward this goal by working together with Wyandotte and Johnson County law enforcement, prosecutors, victim's advocates, child protection workers, and medical providers in the best interest of the victim's physical and mental health and prosecution of his/her perpetrator. Once a child has made a disclosure of abuse and a report has been made to a local child protection service office or law enforcement, a referral is made to Sunflower House. Our Interview Specialists conduct child-sensitive interviews of alleged child victims using proven forensic practices. Specialized medical exams are also provided to children at Sunflower House by forensic medical examiners. Additionally, the families receive advocacy and support services that they need to start on the road toward healing. In 2010, 547 children were seen for a forensic interview and/or medical exam and \$29,455 in in-kind laboratory fees were donated to the organization.
