Law Program 91% of the youth in the law program report that knowing about the law gives them confidence to deal with negative peer pressure. 84% of the youth report they are less likely to break the law. FLY's law and mentor volunteers provided more than 6,547 hours of community service.

Mentor Program 85% of mentors complete their year long commitment. 97 % of the mentees reduce drug and alcohol use within the first 6 months because of the program. 100% of the mentees report that they now have goals and hope for the future because of the Mentor Program.

Peer Leadership Program 88% of the youth participants do not re-offend within their first year in the program. 90% of youth participants report that they are now more engaged in school. Youth performed more than 3,529 hours in community service hours.
