All of our animals are available for adoption. Since our founding in 1996 we have adopted out over 40K+ dogs and cats to the metro Atlanta community.**

**PAWS provides low cost vaccination clinics to the public twice per month. All of our services are focused on providing for the humane treatment of animals and ensuring responsible pet ownership. 
