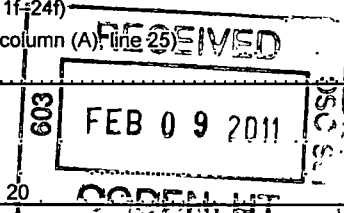

EARLY CHILDHOOD EDUCATION PROGRAMS WERE PROVIDED TO 804 CLIENTS (375 CHILDREN BIRTH TO FIVE YEARS OF AGE AND THEIR 429 FAMILY MEMBERS). THESE SERVICES WERE PROVIDED AT OKC EDUCARE, EMERSON EARLY HEAD START, TONY REYES EARLY HEAD START AND TO PREGNANT WOMEN IN THEIR OWN HOMES. EVALUATIONS OF CHILDREN ENROLLED AT OKC EDUCARE ARE PERFORMED BY AN INDEPENDENT EVALUATOR. CHILD OUTCOMES FOR THE 2009-2010 FISCAL YEAR SHOW SIGNIFICANT GAINS IN AT LEAST 2 AREAS. ALL OF OUR CHILDREN MADE SIGNIFICANT GAINS IN SOCIAL/EMOTIONAL DEVELOPMENT FROM THE FALL OF 2009 TO THE SPRING OF 2010, AS MEASURED BY THE DEVEREUX EARLY CHILDHOOD ASSESSMENT (N=123, P=.002). THE SPRING 2010 AVERAGE T-SCORE OF 48 PUTS OUR CHILDREN WELL WITHIN THE NATIONAL AVERAGE RANGE (T-SCORE OF 50, +/- 10). OUR 3 YEAR-OLD CHILDREN
