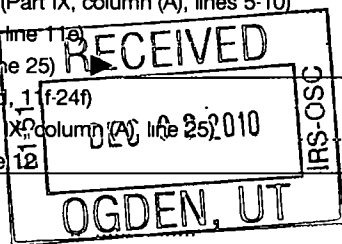

Services include reference, (with online databases, books, periodicals and microfilm collections) Readers's Advisory, Interlibrary Loan and Programs. 15-17% of the annual budget is spent to purchase new materials for use by our patrons.

Summer Reading program, Computer Classes and Miscellaneous programs. In FY 10 30,624 children and teens attended a program at one of our 15 branch libraries, 12,957 young people participated in the Summer Reading Program. Over 820 hours of formal in informal computer instruction was provided to 4,571 patrons. Book signings, local and regional authors talks, and movies and speakers on specialized subjects.
