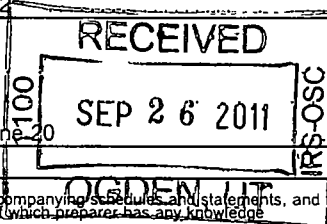

Gethsemane Food Pantry expanded to four days of operation in 2010, working to address hunger in the southwest Houston community. In 2010, the pantry provided assistance for 21,831 persons from 5,547 households.

Back to School - provides disadvantaged students with grade-appropriate school supplies, new clothing and gently used clothing at the start of each school year. A total of 6,160 students received assistance in 2010.
