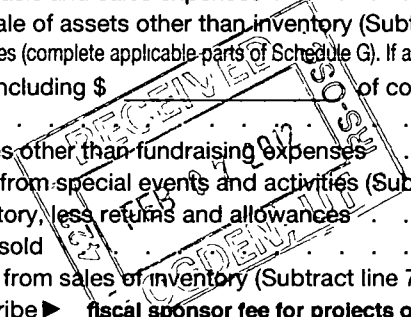



22b The fourth program is Cool Ground (formerly Native Solutions to Conservation Refugees). In FY 2009 this program successfully worked with the Indigenous Mursi people of Ethiopia to protect their ancestral lands.

The organization was loaned the sum of \$13,000 by its co-Directors Anne Petermann and Orin Langelles in March of 2004. This is a no-interest loan that was due to be paid in March of 2007. No payments have yet been paid and the loan has been extended until 2010.

A loan was put on Co-Director Orin Langelles's credit card in the amount of \$9,000 + finance charges on 5/12/09. A total of \$8,953.97 was repaid to him in FY 2009.
