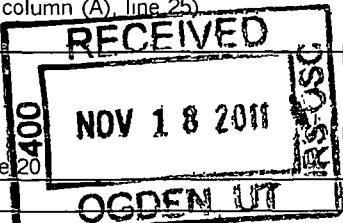

The "Heal as you Feel Program" provided cards, flowers or gift basket to officers or employees of the Denver Police Department at times of medical crisis, death, long-term illness, or other crisis. The program also assists terminally ill officers or family members with meetings, lunch or dinners with others to discuss their medical issues, funeral arrangements and family couesling. The organizaton has assisted in transportation to events such as sports games and helped with the house or yard work.

4c (Code) (Expenses \$ 13,455. including grants of \$ 10,855.) (Revenue \$)

The "Sgt. Thomas O'Byrne Annual Health Fair" program paid costs not covered by insurance to allow the officers and members of the Denver Police Department to participate in obtaining proper shots, blood tests, various scans and proper health and dietary information in order to detect any hidden/unknown illness. The annual health fair is set up and managed by the Technical Services and Human Resources Departments of the City and County of Denver.

Since 1999, this program has assisted over hundreds of officers and their families who have experienced medical emergencies, accidents, injuries, house fires, on-going health issues, and funeral expenses.

The DPOF initiated the "Jacques and Alexisa Bensard Medical Education Scholarship Award" program in 2010. Retired Police Technician Jacques (Frenchy) Bensard submitted a proposal to fund yearly tuition assistance awards through the DPOF.
