ICAN provides free, comprehensive out of school time programs that empower youth to be productive, self-confident, and responsible citizens ICAN offers a variety of free, comprehensive programs for youth ages 5 to 18 years old during our after school and summer/intercession programs Our array of programs is strategically designed to meet the educational needs of our youth while engaging them in something that is fun, not just an extension of the school day We currently provide five program content areas Education, Youth development, Healthy Life Styles, Job Skills Training, and Substance Abuse Prevention within three domains Youth, Family, and Community Henry Salinas founded ICAN in 1991 as an alternative to the growing gang problem in his Chandler, Arizona neighborhood He and several volunteers would drive through the streets to collect teens and take them to participate in activities away from the gang-infested areas They provided supervised activities, mentoring, and encouragement to stay in school and away from gangs It was during this time that Henry recognized the intense and extensive pressures facing the youth, from living in single-parent homes, living in poverty, dealing with friends and parents who use illegal drugs, failing grades in school, and the list goes on Based on their perception, the youth did not believe they had future or value Through his continuous interaction and support of the youth, Henry helped them to achieve a new appreciation of life by showing them the importance of obtaining an education, learning new skills, and having people in their lives who cared for them The youth finally had a place to go free of charge to stay out of trouble and to better their situation and their lives This initial experience is what formed the ICAN of today ICAN has grown from its early beginnings in Henry's car to a 501(c)3 non-profit organization that continues to serve youth from all over Chandler and even beyond its borders With two buildings and 75,000 square feet of property located in the heart of downtown Chandler, ICAN continues to grow in the number of youth served per year and in the strength of our programs Last Year, ICAN served over 1200 participants in our programs One of the most unique aspects of the ICAN programs is that membership has always been free Money is a major barrier for many youth that we serve ICAN accepts everyone, regardless of financial situation, we strive to keep everything free, including membership, programs, transportation, and field trips Our programs have grown from simply getting the youth off the streets to comprehensive prevention programming that operates all year round in our facility as well as offering prevention and family programs in the schools and community
