The Foundation for Hearing Research, Inc (FHR) operates two schools that serve families in Northern California, The Jean Weingarten Peninsula Oral School for the Deaf (JWPOSD) in Redwood City, California and the Children's Choice for Hearing and Talking (CCHAT) in Sacramento, California The schools function independently, but share the same educational model and philosophy Both schools provide intensive auditory-oral instruction and speech/language therapy to children who are deaf and/or hard of hearing Effective early intervention in developing listening, spoken language and cognitive competencies in young children with hearing loss is central to our mission Parent education is an integral part of both programs This focus upon the early development of a child's cognition, auditory and oral speech and language skills helps to prepare them to access mainstream education environments at an early age Our student's auditory and oral communication skills enable them to integrate into the community at large and learn independence in order to think and speak for themselves JWPOSD and CCHAT are recognized as a national centers of excellence for training teachers, speech therapists and audiologists in using hearing technology with children who are deaf and/or hard of hearing
