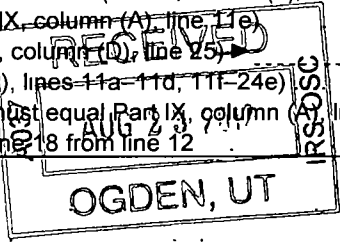

Its mission is to provide nurturing pediatric medical care, medical education and health promotion and illness prevention programs

Hospital Operations Angkor Hospital for Children (AHC) and its related programs located in Siem Reap Cambodia. AHC opened in January 1999 and has offered free comprehensive child health care services to hundreds of thousand of ill and impoverished children. An average of 400-450 children and their families are seen each day through the hospital's outpatient department (OPD). In 2011 more than 130,000 patients visisted the OPD. With 50 beds, the hospital boasts a greater than 90% bed occupancy rate. On average, more than 200 children are admitted each month

HIV/Home Care Program serves many children who are living with HIV/AIDS or chronic illness requiring frequent and consistet medical care. For those living outside of the city of Siem Reap, regular travel to and from AHC is physically or economically impossible. Staff travels to rural communities bringing assessment and treatment directly to the children and support and education directly to the family. AHC is currently the largest such facility outside of the capital city, Phnom Penh, providing lifesaving antiretroviral HIV therapy to children

Medical Education Center (MEC) Program provides short- and long- term training programs. In 2011, it trained 300 AHC medical, nursing and nomedical staff, 362 Cambodia nursing students and 40 of their nursing school intructors, more than 91 government doctors and nurses attending short-and long-term courses/workshops
