

THROUGH THE EXPLORATION OF NORTHWEST ECOLOGY, ECO PROGRAMS INSPIRE STUDENTS TO DEVELOP AN APPRECIATION FOR THEIR LOCAL ENVIRONMENT AND COMMUNITY. THE ORGANIZATION WORKS WITH CHILDREN BOTH IN THE CLASSROOM AND OUTDOORS, WITH THE GOAL OF INSPIRING LONG-TERM INTEREST IN SCIENCE EXPLORATION AND ENVIRONMENTAL PRESERVATION. WE PROVIDE HANDS-ON ECOLOGY-BASED PROGRAMS THAT BEGIN IN KINDERGARTEN AND CONTINUE THROUGH A STUDENT'S ELEMENTARY EXPERIENCE.

ECO CONNECTS STUDENTS TO THE WORLD AROUND THEM THROUGH ITS SCIENCE ENRICHMENT PROGRAMS, SENDING PAIRS OF SCIENTISTS IN RESIDENCE INTO INDIVIDUAL ELEMENTARY SCHOOL CLASSROOMS TO FACILITATE A SERIES OF HANDS-ON ECOLOGY LESSONS. LESSONS OCCUR BOTH INSIDE AND OUTDOORS AND ARE ALIGNED WITH RELEVANT STATE EDUCATIONAL STANDARDS. SCIENCE ENRICHMENT PROGRAMS ARE TAILORED TO EACH SCHOOL'S INDIVIDUAL NEEDS AND TO THE RESOURCES AVAILABLE WITHIN THE COMMUNITY. STUDENTS THE OPPORTUNITY TO STUDY LOCAL WATERSHEDS, WILDLIFE, GEOLOGY AND BOTANY.

THE ORGANIZATION'S SCIENCE ENRICHMENT PROGRAMS MAKE THE MOST OF A SCHOOL'S NATURAL RESOURCES BY TAKING

WALKING FIELD TRIPS TO LOCAL WETLANDS, CREEKS, AND STREAMS WHERE STUDENTS CAN EXPLORE THE ECOLOGY OF THEIR

IMMEDIATE COMMUNITY. IN COORDINATING THESE FIELD TRIPS, ECO OFTEN PARTNERS WITH OTHER ORGANIZATIONS AND

BUSINESSES. FIELD TRIPS OFTEN INCLUDE SERVICE LEARNING COMPONENTS.

DURING THE 2010-2011 SCHOOL YEAR, TEN SCIENCE ENRICHMENT PROGRAMS REACHED 1,620 STUDENTS IN 54 CLASSROOMS

AND INCLUDED EIGHT FIELD TRIPS.

PART III. LINE 29 HABITAT RESTORATION/SERVICE LEARNING.

SERVICE LEARNING COMBINES ACADEMIC CLASSROOM WORK WITH MEANINGFUL SERVICE. ECO PROVIDES ECOLOGY-FOCUSED

SERVICE AND EXPERIENTIAL LEARNING AS AN ADDITIONAL COMPONENT OF OUR PROGRAMS. STUDENTS USE KNOWLEDGE GAINED

IN ECO LESSONS TO MAKE A DIFERENCE IN THEIR COMMUNITY. PROJECTS ARE FACILITATED BY SCIENTISTS IN RESIDENCE, BUT

DRIVEN BY STUDENT WORK AND ENTHUSIASM. PREVIOUS SERVICE LEARNING PROJECTS HAVE INCLUDED THE CREATION OF

OUTDOOR CLASSROOMS ON SCHOOL GROUNDS, WETLAND AND STREAM RESTORATION, INVASIVE PLANT REMOVAL, NATIVE

PLANTINGS, AS WELL AS THE CREATION OF SCHOOLYARD NATURAL AREAS.

SERVICE LEARNING PROJECTS ALLOW STUDENTS TO CONTRIBUTE POSITIVELY TO THEIR SCHOOL AND NEIGHBORHOOD. THE

PROJECTS GIVE STUDENTS A STRONG SENSE OF BELONGING TO THEIR UNIQUE COMMUNITY. ECO SCIENTISTS IN RESIDENCE

FACILITATE THE WORK DURING THE PROJECT TIMEFRAME. IN SUBSEQUENT YEARS, SCIENTISTS IN RESIDENCE UTILIZE THE STUDY

SITE AS AN OUTDOOR CLASSROOM FOR SCIENCE EXPLORATION.
