Project Access Northwest links low income uninsured and underinsured King County patients to volunteer specialty providers in PANW's distributed network of care. Working with the community health centers and free clinics for primary care services, PANW assures access to needed specialty care services by providing case management services for the patients. PANW assures that the pre-visit information such as labs and imaging are available to the specialists at the time of the scheduled appointment. Supported by the case management services, patients show up for appointments, on time, prepared and ready to work with the specialist on his/her care. In 2011, 4087 patients were referred to PANW for medical services in King County. They were served by 1,040 licensed clinicians.

With 5+ years experience in medical specialty care, Project Access Northwest recognized the need for oral specialty care services in the low income population served by the dental clinics in the community health centers. As in the King County medical specialty program, patients have a referral from community health center dentist and need more specialized dental care. Partnering with Swedish, Seattle King County Dental Society and Washington Dental Service Foundation, we provide case management services through the largess of a number of volunteer dentists. We also work with these same dentists to assure the needed oral health clearance for low income uninsured dialysis patients working to get on the kidney transplant list locally.

Project Access Northwest's positive experience resulted in an invitation to expand its services to into Snohomish County, King County's northern neighbor. In 2011, our work included recruiting initial hospital, labs, imaging and other ancillary services. With these in place, we started recruiting physicians and other licensed clinicians. While still a very young program, PANW quickly recruited about 120 licensed clinicians who provided services to 55 patients in the last months of the year.
