## ARTICLES OF ASSOCIATION

### Article I: Name and Organization

The name of this association is The Omprakash Foundation. It was founded in 2005 and is designated an unincorporated nonprofit association created under the laws of the State of Connecticut (Reg. # 0053792) and is a tax-exempt non-profit organization registered under section 501©3 of the Internal Revenue Code (EIN 20-8655418).

### Article II: Statement of Aims and Objectives

Omprakash aims to:

- Improve global education through cross-cultural exchange.
- Help grassroots organizations represent themselves to a global audience and recruit volunteers, donors, and other kinds of support.
- Encourage the development of 'global citizens' by providing a free network of volunteer opportunities to the interested public, and grants to selected volunteers

### Article III: Governing Body

Omprakash is governed by a body of six independent voting members. New members can be added after full consensus approval by existing members. A process is in place for disclosing any conflicts of interest on an annual basis.

### Article IV: Dissolution

Omprakash can be dissolved with a majority vote from the its governing body. If, at the moment of dissolution, Omprakash retains control of assets that donors had earmarked for specific Omprakash Partners, every reasonable effort will be made to fulfill the wishes of these donors. Further assets that have not been earmarked will be transferred to one or several charitable entities selected by a majority vote from the governing body.
