

ADDITIONAL NOTE: Funds sent to the Catholic Church in Haiti and EGI;

In 2011, The Haitian Project acted as fiscal agent for funds given in support of the rebuilding of the Catholic Church in Haiti. One gift of \$50,000 was given and was sent by wire transfer to His Excellency Barney Auza, Nuncio of Haiti, to the Nonciature's bank account in Haiti.

The Haitian Project also acted as fiscal agent for one \$1,500 gift given in support of the Economic Growth Initiative's work in Haiti, which was sent to EGI by check upon receipt. Neither of these gifts appear in The Haitian Project's income & expenses.
