THERE IS EXTENSIVE PLANNING FOR CAMP SESSIONS FOR ADULTS WITH DEVELOPMENTAL DISABILITIES. THE FIRST (INAUGURAL) ATLANTA CAMP SESSION WAS HELD MARCH 14-18, 2011 IN RUTLEDGE, GA WHICH SERVED 36 DISABLED ADULTS WITH HELP FROM 70 VOLUNTEERS. THE SECOND 2011 CAMP WAS HELD OCTOBER 2-6, 2011 AT CAMP HARRISON IN BOOMER, NORTH CAROLINA WHICH SERVED 60 DISABLED ADULTS. SIXTY-ONE VOLUNTEERS WORKED AT THE WEEKLONG CAMP SESSION.
