In 2011, the Esperanza Education Fund awarded college scholarships worth \$115,000 to 13 high school students from DC, Maryland, and Virginia. The students came from Bhutan, Cameroon, Colombia, El Salvador, Ghana, Guinea, India, Mexico, Mongolia, Nigeria, Pakistan, the United States, and Vietnam. They were selected from more than 350 applications. One scholarship worth \$5,000 was revoked due to the scholar's non-compliance with the terms of the award. Net expenses and grants were \$110,000.

The Esperanza Education Fund matches each of its scholars with a mentor, and provides support to the students throughout their college careers. These expenses include travel reimbursement for the mentors to visit their scholars on campus and various events that we host, including "Career Day" and a picnic reunion.

Esperanza grants scholarship awards to students in the year that they apply for and receive the scholarship but disburses the funds directly to the student's educational institution in pro-rated amounts at the beginning of each academic semester throughout the course of the student's education. Scholarships may be revoked due to a scholar's failure to comply with the terms of the scholarship.

To maintain their scholarships, scholars must:

- Enroll full-time at an accredited public college or university.
- Remain in good standing and maintain a 2.5 grade point average.
- Submit yearly transcripts and progress reports to the Esperanza Education Fund; and
- Attend mandatory events hosted by the Esperanza Education Fund, including Scholar Orientation and Career Day.

In 2011, the Esperanza Education Fund awarded college scholarships worth \$115,000 to 13 high school students from DC, Maryland, and Virginia.

Esperanza revoked one scholarship in 2011 worth \$5,000 due to the scholar's non-compliance with the terms of the award. Net grants were \$110,000.
