JOURNALISM HAS TAKEN A SUBSTANTIAL HIT IN THE LAST DECADE ACCORDING TO THE NATION, OF THE 60,000 PRINT JOURNALISTS EMPLOYED IN 2001, AT LEAST 10,000 HAVE LOST THEIR JOBS WHILE NEWSPAPER CIRCULATION DROPPED 7% AND AN AMERICAN JOURNALISM REVIEW STUDY FOUND THAT ONLY 355 FULL-TIME NEWSPAPER REPORTERS ARE STILL BASED IN THE NATION'S STATE CAPITOLS AND THAT 44 STATEHOUSES HAVE FEWER FULL-TIME REPORTERS THAN THEY DID SIX YEARS AGO THE FRANKLIN CENTER WAS ESTABLISHED AS A DIRECT RESPONSE TO THIS DECLINE WE SET OUT AS A NEW ORGANIZATION IN JANUARY 2009 TO RECRUIT, TRAIN, AND PROVIDE RESOURCES FOR JOURNALISTS DEDICATED TO EXPOSING WASTE, FRAUD, AND ABUSE AT ALL LEVELS OF GOVERNMENT IN THE EARLY DAYS OF THIS COUNTRY, BENJAMIN FRANKLIN REALIZED THE POWER A FREE AND UNFETTERED PRESS COULD HAVE ON THEM TO CALL FOR RESPONSIBILITY FROM THEIR LEADERS AND INSTITUTIONS HE WROTE SCATHING LETTERS AND EDITORIALS, AND THEN FOUNDED HIS OWN NEWSPAPER BECAUSE HE BELIEVED THAT THE PRESS COULD BE THE STRONGEST ASSET OF THOSE HOPING TO FOUND A NEW NATION IN 2011 THE FRANKLIN CENTER PROVIDED SUPPORT FOR SEVERAL STATE BASED ORGANIZATIONS TO ESTABLISH NEWS ORGANIZATIONS TO PROVIDE ORIGINAL NEWS CONTENT FOR THE READERS AND VIEWERS IN THEIR STATES
