Land acquisition and conservation easement efforts on multiple properties within the Beavercreek Watershed.

Utilizing funds provided by state sources, BCWA acquired 32.5691 acres of wetlands and associated riparian property within the BCWA footprint plus protected an additional 58.321 acres of wetland via conservation easement within 2011. The land acquired and owned as fee simple purchase is also protected by conservation easement imposed coincident with the transfer of ownership rights. BCWA carries the assets owned on the balance sheet at cost

This additional land will be managed, conserved and protected consistent with BCWA charter.

These policies are reflected in each individual easement document. BCWA has taken steps to supplement their ability to defend and enforce these easements by aligning with the Land Trust Alliance to pool resources and purchase insurance coverage to facilitate protection and enforcement functions. BCWA monitors each property no less often than annually to investigate the use and condition of the properties restricted by the easement to determine if the property owner is adhering to the restrictions imposed by the terms of the easement to ensure the conservation purpose of the easement is being achieved.

During 2011, BCWA contracted with Mark Martel (Trustee) and Martel Art to design, layout and produce graphic designs to be used as brochures and maps for BCWA educational uses. This work was a continuation of services requested in 2010 and provided Mr. Martel with another \$1,000.00 in fees during 2011 that was reported to him on Form 1099-MISC. This expense is included in Property Management expenses in Form 990, Part IX, 24d, column B. The contract was ratified by the Board of Trustees. This payment (\$1,000) is reported on Form 990 Schedule L as required by the instructions to Form 990.

Form 990, Part VI.B.11a. Form 990 is reviewed and approved by the BCWA Administrator and the Executive Committee (consisting of the 4 current officers plus the 2 past Presidents) before presentation to the Board of Trustees. The Board of Trustees reviews and approves the Form 990 (by majority vote) before it is filed. A copy of the Form 990 is made available on the BCWA website and at the Annual Meeting for review by all members and is available upon request.

Form 990, Part VI.B.12c. Beaver Creek Wetlands Association requires that each officer, trustee, employee, and affected member sign a comprehensive Conflict of Interest and Gift Policy and Disclosure form annually. These documents are reviewed and accepted by the Executive Committee (as described above) and retained in vital files. The Trustees and members share the responsibility of monitoring compliance with these policies with any concerns heard and addressed by the President, Vice President or any member of the Executive Committee. This process serves in conjunction with the BCWA Whistle Blower Policy to provide adequate coverage for all BCWA members.

Form 990, Part VI.B.15b. Beaver Creek Wetlands Association employs only one person and only on a part-time basis. Compensation rate for the BCWA Administrator is established and approved by the Executive Committee, based on current market rates for comparable services and level of responsibility. The BCWA Administrator has served in this position for over 12 years, so his rate of compensation reflects his experience, tenure and performance. The Executive Committee reviews the Administrator compensation rate no less often than annually and adjusts accordingly as approved by unanimous consent of the Executive Committee.

Funds were provided under an Ohio EPA program referred to as WRRSP (Water Resource Restoration Sponsor Program) and designated specifically for wetlands acquisition and management. Funds provided were used to purchase the land and the conservation easement rights within 2011. Additional funds provided are designated for land restoration and management and held by BCWA pending utilization and included in Form 990, Part X, line 2B as Temporary Cash Investments. Total proceeds received during 2011 from the WRRSP program were \$710,244.31. Of this amount, \$501,838.58 is reflected as additions to Land & Equipment on Form 990, Part X.10c(B), and Schedule D.VI.1a and 1d, approximately \$58,638.41 was used for property management purposes as required (reflected as a component of revenue in Part VIII.1f and as program service expenditures in Part III.4b and Part IX.24 d) , and the balance is held as Savings & Temporary Cash Investments as reflected in Part X 2(B). The WRRSP program requires the land to be actively managed using original proceeds plus additional organization funds as required under WRRSP guidelines. This funding represents a nonrecurring source of revenue impacting 2011. Annual revenue is anticipated to return to the BCWA long-term average following implementation of the initial land restoration and management efforts required by WRRSP in the near-term. See Part III, 4b for additional information.
