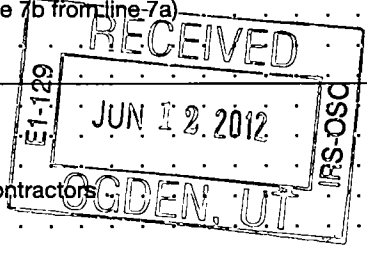

Panza is also working toward building Quixote Village, a permanent supportive housing facility that will consist of 30 very small cottages and a community building that will contain showers, laundry facilities, a communal kitchen, and living and meeting space.

The Village idea came from the founders of Camp Quixote, and the Village design is the product of Camp residents' meetings with a team of pro-bono architects.

During 2011, Panza made significant progress in both improving conditions in the Camp, and preparing to build the Village. Thurston County has agreed to provide a 1.6 acre site for the Village, and fund raising for the Village construction is well underway. We anticipate breaking ground either in the fall of 2012 or the spring of 2013, and moving into the Village before Christmas, 2013.
