This is accomplished by initiating and building regional organizations across the state that will identify needy individuals and families, raise funding, and coordinate volunteers to construct ramps.

 In the 5½ years of our existence we have raised over \$900 thousand in grants and donations, utilized \$2,100 thousand of in-kind donation of services, and received \$352 thousand in payment from third parties for ramps constructed. These resources funded the start-up of 20 regional operations that constructed 2,326 ramps at no cost to the recipients using volunteer labor. 778 of these were constructed in 2011. Year to year growth has been solid and consistent and is expected to continue throughout 2012
