Sponsor a Child. Currently, 30 percent of all children in Kenya are orphans. Rejected by members of their own extended families and communities, they fall prey to fatal yet preventable diseases, drugs, human traffickers and thoughts of suicide. Every 15 seconds, a child in Africa is orphaned by HIV. Of the 2.4 million orphans in Kenya, half are orphaned by this disease which is leaving an entire generation of children without parents.
