The Crisis Center Program (Housing and Supportive Services) provides free, accessible, bilingual and culturally appropriate case management and housing advocacy services to families, youth and single individuals who are homeless or at risk of becoming homeless Crisis Center staff work in partnership with clients to obtain and maintain housing stability Since opening its doors in July of 2002, the Crisis Center has served over 6,500 households In 2011, LCN significantly expanded its scattered site supportive housing for youth and families, which was part of the organization's strategic plan adopted in early 2011

The Solid Ground Supportive Housing Program provides safe, stable housing for homeless male youths, aged 16 to 21 These young men can stay at Solid Ground up to two years, during which time they benefit from comprehensive case management services focusing on a holistic, strength-based approach, as well as educational and vocational training and support The purpose of the Solid Ground Supportive Housing Program is to provide homeless and at risk youths with an opportunity to create a meaningful and positive future for themselves

The Esperanza Trabajando Program is La Casa Norte's job readiness, training and placement program It provides a range of job readiness services helping individuals prepare for employment

The Casa Corazon Program, launched in 2009 is a homeless youth engagement initiative targeted at homeless youth aged 18-24 with a focus on Chicago's west side populations This program provides street outreach, drop in center and comprehensive case management services to youth In 2010, La Casa Norte received a \$1 million pledge for the future development of a new building that will contain administrative offices, significant new housing, and expanded program services A portion of the gift in 2010 was used to purchase property In 2011, LCN worked with its real estate development team on the architectural design of the project, as well as the zoning regulations necessary to build on the proposed site

The Casa Corazon Program, launched in 2009 is a homeless youth engagement initiative targeted at homeless youth aged 18-24 with a focus on Chicago's west side populations. This program provides street outreach, drop in center and comprehensive case management services to youth. In 2010, La Casa Norte received a \$1 million pledge for the future development of a new building that will contain administrative offices, significant new housing, and expanded program services. A portion of the gift in 2010 was used to purchase property. In 2011, LCN worked with its real estate development team on the architectural design of the project, as well as the zoning regulations necessary to build on the proposed site.
