In 2011 the Land Trust placed a conservation easement on 580 acres of forest land that protects over 3 miles of frontage on three class 1 trout streams. The Land Trust placed a conservation easement on 24.1 acres of land at the confluence of the Peshtigo and Little Peshtigo Rivers. We fielded 18 inquiries from people interested in protecting land. We monitored 40 protected properties. NEWLT began a formal partnership with the Nature Conservancy and Ducks Unlimited to protect and restore land in the Green Bay west shore region. Our land stewardship program distributed materials and resources for landowners. A marketing plan was created. All staff, President & Treasurer attended land trust training at Land Trust Alliance Rally. Our office moved to a larger suite. NEWLT hired two additional part-time staff.
