Tapestry's main programming falls into several dance categories, that is, Contra, International, English Country, and Nordic. Tapestry also offers a variety of other styles including Family Folkdance, Cajun, Tango, Irish, Persian, Square, Vintage, and Blues. Tapestry contracted with over 190 artists to support the Tapestry programs. Along with the Minnesota History Center, Tapestry cosponsored Nine Nights of Music and provided dance instructors. In addition, Tapestry provided over 1,100 hours of affordable space to arts organizations and individual artists for rehearsals, dances, or classes in music and/or dance.
