We work to accomplish our mission of empowering individuals to live and work in peace through meeting people's basic needs, leadership development, and formal education.

Adult ELL classes at beginning, intermediate, and advanced levels are provided. ELL classes offer students assistance with reading, writing, listening and speaking skills as well as cultural adjustment instruction in areas such as finance, employment skills, nutrition, health, social customs, etc. Additionally, high school and college tutoring is available for new Americans that have a good grasp of the English language and American customs and systems. 237 individuals were serviced in ELL classes.

There are three branches to Social Services and those include: Case Management/+Advocacy, Basic Needs, and Mental Health Services. Advocacy and case management services work to address language and cultural barriers and provide assistance to help people navigate the various systems affecting their lives. MORE was founded on the principle that all people deserve to have their most basic needs of food and clothing met. We do that through weekly distributions of food and donated household goods. Mental health services provided to participants include: assessment and referral, individual/family counseling. Karen elders support group, education surrounding mental health and cultural adjustment issues, and crisis intervention. Advocacy/Case Management- 936 (duplicated) were served. Basic Needs- 1710 (duplicated) were served. Mental Health - 58 participants.
