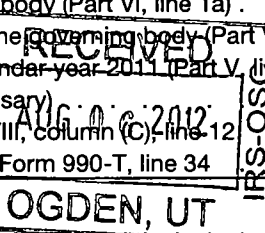

Kingdom House's mission is to help our clients break out of the poverty cycle by providing day care services, a neighborhood food pantry, employment services, elderly services and youth programs. Kingdom House has been providing services in this neighborhood since 1902.

Kingdom House Day Care Center provides child care for low income families who are working or attending school or vocational training. We provide day care for 94 children ages six weeks to six years of age. Kingdom House's infant/toddler and preschool programs have accreditation under the Missouri Voluntary Accreditation Program and is a member of the Child Day Care Association of Saint Louis which provides technical support and in-service training services. Head Start and Early Head Start are part of Kingdom House's Day Care program.

4b (Code:) (Expenses \$ 600,119 including grants of \$ 88,792) (Revenue \$ 750,169)

Kingdom House's Youth Programs include an After School program for children ages 6 to 14 that provides tutoring, arts & crafts, computer training, sports & fitness, field trips and a meal each day after school. Kingdom House also provides a seven week Summer Camp for between 150 to 185 children. During Summer Camp all kids are provided breakfast and lunch each day. The Sports program includes baseball, basketball, soccer and cheer leading all at no cost to the participants. Kingdom House Youth Program also includes a Youth Employment program where participants are Peer Counselors during the After School program as tutors.

4c (Code:) (Expenses \$ 461,688 including grants of \$ 2,500) (Revenue \$ 437,834)

Kingdom House's Core Social Service programs include the Family Center for emergency respite for up to ten children; the Food Pantry which provided 107,796 pounds of food for needy individuals and families in 2011; Family Support programs which address child neglect and abuse in the Saint Louis metropolitan area, and financial literacy and English classes.

Kingdom House also has a Thrift Shop for daily necessities and clothing items. In addition, Kingdom House will provide referrals to other resources in the area to help "break the cycle of poverty".
