Exhibition Programs: The Contemporary Art Museum St. Louis (CAM), a non-collecting
institution, presents exhibitions in a wide variety of contemporary artistic styles and
media, created by diverse national and international artists. CAM is recognized as one of
the top ten contemporary art institutions in the country, and continues to capture
the acclaim of colleagues and critics for its innovation, energy, and artistic merit.
Three exhibitions in the the main galleries, featuring a total of twelve artists, were
presented in FY2011. In addition, twenty-eight artists were presented in The Front Room, which
offers short projects at an accelerated pace. CAM is committed to supporting
talented artists working in the St. Louis region through a permanent Flat Files program, and an
annual City-Wide Open Studios program. In FY2011, 162 artists participated in the City-Wide
Open Studios. Total attendance from July 2010-June 2011 was 25,329.

Public Programs: Alongside our exhibitions, CAM demonstrates its commitment to improving
the quality of life in St. Louis by presenting an assortment of free and accessibly priced public
programs. CAM's public programs are designed to engage diverse audiences while providing
meaningful experiences with art being created today. CAM hosted over thirty public programs
in FY2011, attended by 4,831 visitors. These programs are often exhibition-related and include
artist talks, lectures, performances and workshops. CAM also offers regular museum tours led
by staff, in addition to iPad interactive tours featuring interviews with artists and curators.

Youth Education Programs: CAM upholds its mission to foster creativity and access to the arts
for young people of St. Louis through an assortment of free educational programs. CAM's
New Art in the Neighborhood program is now in its 16th year of identifying, training, and
encouraging teen artists. Students document their artistic efforts by creating a portfolio that
can be used for employment or additional education. Forty students participated in twenty-four
half-day sessions over two semesters. Teen Museum Studies introduces students to a variety of
museum careers through workshops led by each of the museum's departments. Twelve students
participated in twelve half-day sessions. ArtReach brings CAM into St. Louis public high schools
where students experience hands-on activities. CAM partnered with thirteen schools in FY2011
to reach over 400 students.
