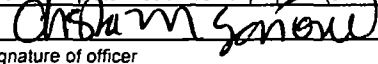
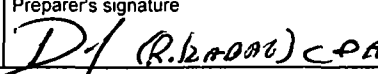

Law Program. 93% of the youth in Santa Clara County report that knowing about the law gives them more confidence to deal with negative peer pressure. 91% of the youth in San Mateo County have reported that they want to make positive changes after being in FLY.

Mentor Program: 100% of the mentees report that the Mentor Program has given them access to a positive adult role model. 96% of the mentees report that they are less likely to break the law after being part of the Mentor Program.

Peer Leadership Program. 98% of youth in Santa Clara County report that after the program they are more likely to make healthier choices. 96% of youth in San Mateo County report that they want to make positive changes after being in FLY. 75% of youth in both Santa Clara and San Mateo County are not found delinquent of a new charge during the same program year.
