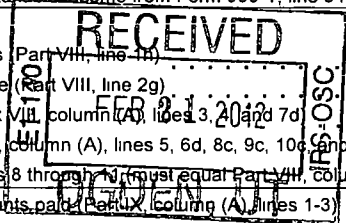

THE SUMMIT ALSO HAD 712 NEW CLIENTS OVER THE COURSE OF THE FISCAL YEAR.
