ALL OF OUR ANIMALS ARE AVAILABLE FOR ADOPTION. SINCE OUR FOUNDING IN 1967, WE HAVE FOUND PERMANENT HOMES FOR OVER 42K DOGS AND CATS WITHIN THE METRO ATLANTA COMMUNITY. PAWS ATLANTA OPERATES AS A NO KILL ANIMAL SHELTER WITH NO ANIMALS BEING EUTHANIZED DUE TO SPACE OR TIME CONSTRAINTS.
