Line 28: Describe what was achieved in carrying out the organization's exempt purposes:

Part III: Line 28

During 2011, Hillsborough House of Hope (HHH) accommodated approximately thirteen former female prison inmates. The ladies, prior to their jail release, were selected for the residential program based on recommendations from the correctional facility staff and interviews conducted by HHH staff. Upon the ladies' release, they were accepted into HHH, where they received a room to live, clothing, personal hygiene items and groceries.

Once in the program, the ladies receive assistance to find employment, enroll in appropriate government assistance programs (Medicare, food stamps, ect.) and secure transportation to and from their employment. While living in the house, they are responsible for their own cooking, room and house cleaning and laundry. The ladies attend Bible study as well as several different types of counseling sessions dealing with financial budgeting, childcare, career training and other courses.

Since opening 10 years ago, 73 women have gone through the one-on-one program. The initial residence can house up to three ladies at a time and the extended one has room for three. Approximately 65 percent have successfully completed the program.
