The Clinic provided 6,445 patient visits to uninsured residents of Broward County, FL in the areas of general medicine, cardiology, dermatology, gynecology, psychology, urology and hematology. Patients were provided with free medical consults and preventative educational literature and free or low-cost laboratory testing. The Clinic has 209 volunteer staff of which 33 were liensed healthcare providers who provided a total of 4,877 hours of volunteer service. The Clinic also conducted 26 community outreach health fairs/screenings with a total of 924 attendees.
