Garden City Harvest's mission is to build community through agriculture. We do this by growing food with and for people with low incomes, by offering education and training in ecologically conscious agriculture, and by using our sites for the personal restoration of youth and adults. We accomplished this at our 4 neighborhood farms, 7 community garden sites and 5 school gardens in 2011. While each of our neighborhood farms is unique, they all share in growing food for Missoulians in need, distributed by the Missoula Food Bank, the Poverello Center (homeless shelter and soup kitchen), Youth Homes, and other local service agencies. In 2011, we delivered over 33,000 pounds of fresh, locally grown produce to these agencies. We also grew produce for 175 CSAs (which stands for Community Supported Agriculture, or vegetable subscriptions). We have 290 community garden plots at 7 different locations throughout the community. There, longtime gardeners and newcomers garden side-by-side and learn from each other. Each community garden provides participants with a 15 by 15 foot plot of land, tools, water, compost, straw, and the knowledge and guidance of a garden coordinator. In 2011, 75% of our community gardeners were from low to moderate income households. Gardens reduce stress on food budgets. They teach an essential skill: how to grow your own food. Our Community Education Program connects Missoulians to their food and the place it is grown. Taking a hands-on, farm-based approach, we encourage children and adults to explore connections between food, agriculture and their everyday lives. We helped construct a new school garden and outdoor learning center at Paxson Elementary School in 2011. We offered farm field trips to almost 4,000 kids and adults, held summer camps for grade school kids. In 2011, we piloted "Farmer in the Classroom" in 2 elementary schools. We also offer a practicum class for University of Montana students each year, as well as college student internships at the PEAS Farm. The Youth Development Program offers farm-based work to at-risk teens, using farming as a means of therapy. Twelve teens were referred to this program through the Missoula Youth Drug Court, school counselors, teachers and Youth Homes in 2011. The teens were given meaningful work planting, growing and harvesting produce. They created connections with diverse groups of people in a way that helps to broaden the teens' view of their world. Youth operated the Mobile Market, offering fresh produce at reduced prices to low-income senior citizens, families and disabled adults at 6 subsidized housing facilities in 2011.
