ByLaw Amendment

Section 3. Term of Office.

The board shall be divided into three roughly equal classes with one-third of members' terms expiring each year. At each annual meeting the Board shall nominate and elect trustees to fill expiring terms for a term of three (3) years. In the event the Board is expanded, as permitted by these ByLaws, the terms of the new members shall be staggered in a fashion so as to maintain the roughly equal classes. A new trustee may be appointed for a term of less than three (3) years if it is necessary to do so maintain the equality of the classes.
