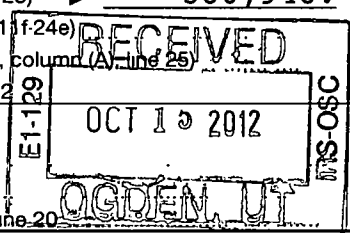

THE GARDEN FOSTERS CULTURAL AWARENESS THROUGH ITS MANY PUBLIC PROGRAMS, INCLUDING TRADITIONAL FESTIVALS, ART EXHIBITIONS, LECTURES, WORKSHOPS, GUIDED TOURS, EDUCATIONAL PROGRAMS, AND MORE. THE 5.5 ACRE JAPANESE GARDEN IS COMPOSED OF FIVE DISTINCT GARDEN STYLES: FLAT GARDEN, STROLLING POND GARDEN, TEA GARDEN, NATURAL GARDEN AND SAND AND STONE GARDEN. MORE THAN 223,000 GUESTS VISITED THE GARDEN IN 2011.
