We added one new state affiliates in 2011: Delaware.4c (Code: ) (Expenses \$ 173,398. including grants of \$ ) (Revenue \$ )California IPL:California Interfaith Power and Light (CIPL) educated its congregations about global warming and advocated for equitable and effective climate policies at the state level. Highlights for the year included an "Energy Oscars" event honoring 15 congregations for their accomplishments saving energy and utilizing clean energy, a number of houses of worship going solar, and cumulative emissions reductions of 24.6 million pounds.
