The WMMC Foundation supports White Memorial Medical Center (WMMC), which is a full service 353-bed, non-profit, faith-based hospital that provides a full range of inpatient, outpatient, emergency and diagnostic services and is located just minutes from downtown Los Angeles One of the greatest assets an organization can possess is the trust of its community --both internal and external WMMC devotes a significant amount of financial and human resources to carry on its legacy of close to 100 years of community-centered service to medically underserved communities in our area Beyond our role as one of the leading providers of health care in our community, we are committed to operating as a socially responsible organization as we meet the needs of our different stakeholders--our patients, physicians, workforce, neighbors, partners and donors Our goal is to enable people to achieve more than just good health, it is to create opportunities for growth and development that will make a real, lasting impact on the health of our community WMMC serves a community whose residents are predominantly Latino and where over 41% of families earn under \$15,000, which is below the federal poverty level WMMC is positioned to provide this historically medically underserved population with Latino-focused language programs and education, including Spanish bilingual doctors and nurses and is dedicated to providing all its patients with the same level of high quality health care This care includes highly advanced specialty services including advanced certifications, specialty care services and state-of-the-art procedures WMMC has adopted rigorous national quality standards and has won four Eureka Awards for Performance Excellence from the California Council on Excellence WMMC mission anchors everything we do and extends out to the community in many ways Collaborative efforts between WMMC, local organizations and donors has created critical programs needed to address the specific health care needs of the more than 2 million residents living throughout eastern Los Angeles Together we can change the outcome of our community's health For example, the Cecilia Gonzalez De La Hoya Cancer Center, named for the late mother of champion boxer and philanthropist, Oscar De La Hoya, helps address the area's high incidence of breast cancer The Cancer Center features sophisticated diagnostic and treatment equipment, bilingual breast cancer support groups, a community resource center and free breast exams and mammograms to women who are uninsured or underinsured The Diabetes Care Center at WMMC addresses the high prevalence of diabetes within the community and provides full-service diabetes testing, education, peer counseling and follow-up care and runs a successful Healthy Eating & Lifestyle Program (H E L P), a six-week program designed to teach children, at-risk of developing diabetes, the benefits of a well-balanced diet and regular exercise No insurance is needed to access this bilingual program Recently our at-risk newborns, cared for in one of the few Level III Neonatal Intensive Care Unites in Los Angeles, have been protected by state-of-the-art technology--neo blue lights These lights were purchased with donations received through the White Memorial Medical Center Foundation Babies are safer and have a better chance of flourishing because friends of the WMMC contributed to this successful fundraising effort A significant portion of the mission-driven benefits that WMMC provides to its community is intangible or otherwise difficult to quantify The following brief story illustrates this reality In November 2010 Philip Murray Simmons was getting ready to board a Greyhound bus to visit his sister in Texas when he suffered a devastating stroke He awoke at White Memorial not knowing who he was or what had happened to him, with his wallet missing he had no ID, and believed he'd been robbed For a long time no one knew who Philip was, he was listed as John Doe He had no insurance and was denied Medi-Cal Yet for four months our physicians and medical staff went the extra mile to provide him with all the care he needed to slowly begin fighting his way back to recovery Finally in March 2011 Philip was well enough to leave White Memorial--but he couldn't live on his own and he needed continued care for his recovery His only relative was his sister in Texas But neither Philip nor his sister had the funds to get him there Seeing the need, a team of social workers, case managers and nurses swung into action As a team they secured a flight and then obtained a donated walker and wheelchair from WMMC vendors The hospital home health liaison identified a qualified home health volunteer to accompany Philip to Texas who then paid for her own trip Social workers coordinated with Philip's sister Nurses, therapists and physicians worked tirelessly to improve Philip's functionality to enable him to fly safely Another employee secured a donated ambulance ride to get Philip to the airport and assisted in making final flight arrangements A friend found Philip's wallet and ID in the luggage he'd left behind at the bus station all those months ago and brought both to him at the hospital Despite the barriers, the team's persistence and tireless work paid off When Philip left, the team had tears in their eyes, proud and happy of the vital part they had played in his care and in getting Philip to Texas and into his sister's arms Today Philip's condition continues to improve under the safe and loving care of his sister This is just one example on how our White Memorial employees, a family of caring individuals go above and beyond each day to meet the health care needs of our community It takes special people to create change, people with a passion for making a difference in the lives of others Not just because it is the right thing to do, but because their passion to help those less
