Club Passim put on 432 concerts with 33,249 patrons in 2012. In 2011, we also held 432 concerts with 32,500 patrons. In addition to our regular concerts, we held a variety of special concerts, including our monthly Celtic Music Mondays. We help develop emerging artists by offering them the opportunity to perform to smaller audiences and opening for better-known musicians. We also hold 3 weekend-music festivals ("Campfire Festivals") at major holidays that provide an opportunity for lesser-known artists to play. Our audience typically ranges in age from 25-65 and comes mainly from metropolitan Boston.

In 2011, the Fund gave out \$33,000 in grants ranging from \$500-\$2,000 to twenty New England-based artists.
