990 Part III question 4 4a Equal Opportunity Education Two reports were published in 2012 The first report examined student learning gaps in the Jefferson County KY school system (Louisville Metro Area) The second report examined the efficiency of the KY State public schools overall These two reports are available to the public upon request via printed copies, via download from the website, and can be emailed as printable documents The findings of these two reports were the source of many educational programming and outreach efforts, including state and local media, radio interviews and discussions, and a speaking tour The speaking tour involved members of the BIPPS staff traveling to meet with various local and state civic groups, concerned citizens, and educational organizations to discuss the findings of the two reports Other tangential educational issues were also discussed There has been an increase in awareness in the state of the current situation of public education, especially in Jefferson County, and interest in what measures may improve student learning outcomes Suggestions for public policy changes have been discussed that would ameliorate the current low test scores of KY students compared to other states and to first world nations in general No admission or fees were charged to any individual participants or organizations Expenses \$29488 31 (does not include salaries and other allocated expenses) No Revenue 4b Energy Policy As the state of KY relies on coal related industries for energy needs, employment, and for local/county and state tax revenue, in 2012 a lecture series was instituted to discuss the future of coal in light of current movements by various special interest groups to curtail coal production and use The lecture series involved members of the BIPPS staff traveling to give lectures to various state and local civic groups and concerned citizens Lectures included question and answer sessions immediately following to help increase comprehension of this important state issue There is a great interest, especially in the eastern and far western areas of KY concerning the cap & trade proposals currently on the table in congress and around the world, and how these policies, if enacted, would affect local and county economies, as well as the state economy at large Participants in the lecture series were provided with important information about how such policies could affect them personally in the future citizens will be able to use the information provided to them to make informed decisions Public policy solutions have been discussed that will incorporate the needs and interests of KY citizens No admission or fees were charged to any individual participants or organizations Expenses \$23961 31 (does not include salaries and other allocated expenses) Revenue none 4c TAC -
