DREAMER & AFFILIATE SUPPORT - THE I HAVE A DREAM FOUNDATION PROVIDES GUIDANCE, RESOURCES, AND TECHNICAL ASSISTANCE TO 25 I HAVE A DREAM AFFILIATES ACROSS THE NATION, WITH THE GOAL OF ENSURING THAT OUR 3,368 STUDENTS, CALLED "DREAMERS", GRADUATE FROM HIGH SCHOOL PREPARED TO ENROLL IN AND COMPLETE COLLEGE. THE MANAGING DIRECTOR OF AFFILIATE OPERATIONS AND SUPPORT WORKS DIRECTLY WITH AFFILIATES TO PROVIDE CUSTOMIZED PROGRAM SUPPORT THROUGH SITE VISITS, PHONE CONSULTATIONS, AND OTHER TECHNICAL ASSISTANCE. IN ADDITION, THE MANAGING DIRECTOR OF AFFILIATE OPERATIONS AND SUPPORT DEVELOPS AND MANAGES NATIONAL PARTNERSHIPS TO PROVIDE CURRICULA RESOURCES (AT NO COST) TO OUR DREAMERS AND AFFILIATES, WHILE ALSO HOSTING CONFERENCE CALLS AND WEBINARS TO SHARE BEST PRACTICES. THE FOUNDATION ALSO SPONSORS AN ANNUAL LEADERSHIP DEVELOPMENT CONFERENCE WHICH WAS HELD IN 2012 AT DRAKE UNIVERSITY FOR MORE THAN 90 MIDDLE AND HIGH SCHOOL DREAMERS AND AFFILIATE STAFF BROUGHT TOGETHER FROM ALL PARTS OF THE COUNTRY. THIS PAST YEAR, THE FOUNDATION LAUNCHED THE GROWTH MODEL, LED BY A NEWLY FORMED PROGRAM TEAM, TO BEGIN TO SCALE UP OUR EFFORTS TO IMPACT EVEN MORE STUDENTS. IN CONJUNCTION WITH PROGRAM PARTNERS, THE "I HAVE A DREAM" FOUNDATION PILOTTED 16 WORKSHOPS ACROSS THREE HIGH SCHOOLS IN NYC INCLUDING -BILINGUAL FAFSA WORKSHOP FOR STUDENTS AND THEIR FAMILIES-STEM ROBOTICS WORKSHOP FOR 9TH AND 10TH GRADERS-WEST POINT CADETS MENTOR JUNIORS ON COLLEGE APPLICATIONS AND END OF YEAR PRESENTATIONS-A SERIES OF TRANSITIONING TO COLLEGE WORKSHOPS WITH SENIORS-A SERIES OF FINANCIAL EDUCATION MODULES INTEGRATED INTO THE COLLEGE READINESS COURSE. ADDITIONALLY, THE FOUNDATION COLLECTED PRELIMINARY DATA FROM STUDENTS, TEACHERS AND VOLUNTEERS ON THESE PILOTTED WORKSHOPS.

PROGRAM STRATEGY & DESIGN - THE "I HAVE A DREAM" FOUNDATION IS WORKING TO INCREASE THE ORGANIZATION'S IMPACT BY CONSTANTLY IMPROVING OUR EFFORTS TO SUPPORT CURRENT AFFILIATES. AS PART OF THIS EFFORT, THE FOUNDATION CONDUCTED SURVEYS TO EVALUATE CURRENT PROGRAM OFFERINGS ACROSS THE AFFILIATE NETWORK AND PROVIDED RESOURCES TO ADDRESS AREAS THAT NEEDED IMPROVEMENT. AT THE SAME TIME, THE FOUNDATION COMPLETED THE DESIGN OF A NEW PROGRAM MODEL THAT WAS LAUNCHED IN EARLY 2012. THE NEW MODEL BUILDS ON THE ORGANIZATION'S PAST SUCCESSSES AND AIMS TO INCREASE COLLEGE GRADUATION RATES WHILE SERVING MANY MORE STUDENTS EACH YEAR.
