Cat's Cradle seeks to ensure and maintain a safe, compassionate community for cats and dogs in the Shenandoah Valley. Emphasis is on aggressive spay/neuter of owned animals and TNR (trap/neuter/return) of feral cats.

Adoption Program - 386 cats were adopted in 2012, averaging about 32 cats per month. Cats were adopted from our Adoption Center in Harrisonburg, local PetSmart & Petco stores and PetSmart in Northern Virginia every other Saturday as well as through the internet. All cats were altered, tested, vaccinated and treated for parasites prior to adoption. Many of these cats were rescued and came to us injured or ill requiring additional vetting expenditures to ready for adoption. Cats were also taken in from area organizations, such as Page Animal Shelter, Shenandoah Valley Emergency Vet Services, VA AdvoCats, and Shenandoah Valley Animal Services Center. In addition 211 cats were transported to North Shore Animal League in New York City for adoption and one to Best Friends in Kenab, Utah for specialized care. Contributed veterinary services in the form of discounts totaled \$6,056.

4b (Code:) (Expenses \$ 73,473 including grants of \$ 0) (Revenue \$ 8,273)

Spay/Neuter Program - 1,476 cats were altered during the year including 192 readied for adoption. In addition one dog was altered. The program provided spay/neuter assistance to approximately 270 clients with their animals and two businesses caring for cat colonies. In addition we partnered with the Shenandoah Valley Spay/Neuter Clinic to provide low cost spay/neuter to Rockingham, Page, and Augusta counties as well as the cities of Elkton, Timberville, Grottoes, Harrisonburg, Staunton, and Broadway. Services included transportation, trapping, and financial assistance or any combination thereof depending on the client needs. Most people provided some level of copay. Two newsletters were published in 2012 as well as three informational appeal letters to a mailing list of approximately 5,800. An eNews letter was distributed monthly to 2,300 clients and supporters. Brochures were printed and are available in many public places and are provided at community tabling events. Contributed veterinary services in the form of discounts totaled \$11,954.

This resulted in the removal of multiple small dollar items previously capitalized; (1) Used washing machine, -\$398, (1) Dishwasher, -\$710, and (118) Humane traps, -\$4,793. Adjustment offset to Retained Earnings.
