Project Access Northwest collaborates with the health care community to open doors to medical and dental care for the low income individuals through a distributed network of donated care that assures appropriate access to medical and dental specialty care services

PANW links low income uninsured and underinsured King, Snohomish and Kitsap County patients to volunteer specialty providers in PANW's distributed network of care Working with the community health centers and free clinics for primary care services, PANW assures access to needed specialty care services by providing case management services for the patients PANW assures that the pre-visit information such as labs and imaging are available to the specialists at the time of the scheduled appointment Supported by the case management services, the patients show up for appointments, on time, prepared and ready to work with the specialist on his/her care In 2012, 3870 patients were referred to PANW for medical services in PANW's three county service area They were served by 1060 licensed clinicians

With many years of experience in the medical specialty area, PANW recognized a similar need for complex oral specialty care services in the same patient population as served by PANW's medical program In partnership with the community health centers, specialty dentists and Swedish Medical Center, PANW provides similar case management services for the low income, uninsured with complex oral health needs that cant be addressed by the community health center dentists We work with these same dentists to assure that dialysis patients needing oral health care services and an oral health clearance is obtained as part of moving onto the kidney transplant list In 2012, 883 patients were referred to PANW for dental services in King County These patients had an average of 3.7 extractions each
