The Executive Director reviews the final version of the 990 and the 990 is emailed to the board before filing.

The Board HR committee looks up salary information from comparable organizations online and makes recommendation to the full board. The full board, minus the Executive Director, votes on the proposal. The vote is documented in the meeting minutes.
