CONSTRUCTION OF THE MERLET CENTER: The Center is the 7000 sf administrative headquarters for HAPI. The facility includes admin. offices, artisan production and merchandise areas, loan offices, classroom space for both formal education and community seminars, and space for future computer cafe. The facility is constructed of insulated concrete form block that is fire, hurricane, and earthquake resistant in the event that community emergency shelter is needed. It is equipped with a 20,000 gallon cistern and 5KW of solar energy.
