MORE CHURCHES is a modular program for church planting in which leaders are challenged to plant new churches through a proven strategy. Practical skills, biblical training, mentoring and follow-up form part of this intensive action/reflection model. STRONGER CHURCHES - a process to strengthen the local church. Diagnostics tools help assess the church's health, leading healthy conversation and strategic planning.

Latin America - training and resources are provided to a network of national leaders throughout Latin America who train congregations and individuals in church growth, church health and church planting. Our objective is to provide this training and these resources to typically under-resourced areas in order to grow strong churches in towns and neighborhoods throughout Latin America - even in the most remote areas. Strong and healthy churches are proven to effect positive change in the lives of individuals and communities by sharing and applying the message of Gods work through Jesus Christ. The MNM program results for 2012 were as follows: 2,318 national leaders active in church planting training, 61,721 people who were reached with the gospel, 20,343 people now follow Jesus, 5,502 people have been baptized, 4,963 people were trained to lead small group Bible studies, 5,170 small group Bible studies were formed, 29,277 people are now attending those small groups, and 3,716 leaders are working with these groups in addition to the church planter.

**4b** (Code: ) (Expenses \$ 690,461 including grants of \$ 614,963 ) (Revenue \$ 0 )  
Asia - Church planting and Scripture placement. Asia is an area of growing ministry opportunity for MNM and during 2012 the organization developed more ministry relationships and continued to build on it's base. We have observed that already passionate and committed Asian church leaders who serve in under-resourced areas are especially in need of training in evangelism and discipleship in order to establish and grow healthy churches. We provide both scriptures and the type of needed training to those leaders with limited access to these resources. In 2012, over 141,193 Bibles were provided to those who didn't have one. The MNM program results for 2012 were as follows: 100 national leaders completed training and planted a church, 61,700 Evangelistic contacts were made, 16,200 people who now follow Jesus, 300 Bible study groups formed, 5,700 people attending those Bible study groups.

Africa - training and resources are provided to a network of national leaders throughout East Africa who then train other leaders in effective church growth, church health and church planting. We have taken the lessons learned in Latin America to accelerate growth. The MNM program results for 2012 were as follows: 276 National leaders completed training and planted a church, 24,429 people reached with the gospel, 15,486 people now follow Jesus, 6,914 people who have been baptized, 1,249 people were trained to lead small group Bible studies, 866 small group Bible studies were formed, 7,982 people are now attending those small groups, and 888 leaders are working with these groups in addition to the church planter.
