Dharmagiri-Khuphuka Project

BGR provided grants of \$24,061 to Dharmagiri Foundation for their Khuphuka project. This initiative provides emergency food relief to alleviate the suffering of vulnerable households in the communities of Mqatsheni, Kwathunzi and Kwapitela in South Africa, and provides more sustainable solutions to the households' food security issue such as supporting families to obtain social government security grants to which they are entitled through our information and advocacy service, and through the creation of a food garden.

Kalyanamitra Fund - Bodhicitta-India Women's Livelihood Program

BGR provided a \$23,000 grant to The Kalyanamitra Fund's Bodhicitta Vihara for their Women's Livelihood Program in Nagpur, India. This project's aim is to promote Women and build their capacity for sustainable livelihood and support their socio-economic status as well as building awareness on health issues of both women and children. Empowering women economically will also help their families and take the sole burden of financial support off men.

Badlao Foundation

BGR provided a \$22,100 grant to BADLAO FOUNDATION for the purpose of improving the economic status and living condition of 150 marginalized families of Deoghar District of Jharkhand State of India. Deoghar is one of the most backward districts in India and is plagued with economic stagnation, low agricultural productivity, food insecurity, population pressure, chronic indebtedness and forced migration. No development can be sustained if it is not supported by economic improvement and financial independence of the women. This project will try to address both these issues and so can lead to a sustainable economic improvement in this principally agrarian community. The project will result in effective use
