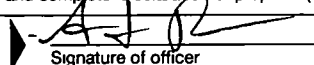

In 2012, the Esperanza Education Fund awarded college scholarships worth \$120,000 to 10 high school students from DC, Maryland, and Virginia. The students came from Bolivia, China, Colombia, the Dominican Republic, Ecuador, El Salvador, Ethiopia, Honduras, and Mexico. They were selected from more than 250 applications. One scholarship with \$3,708 remaining was revoked due to the student's transfer to a private college.

The Esperanza Education Fund matches each of its scholars with a mentor, and provides support to the students throughout their college careers. These expenses include travel reimbursement for the mentors to visit their scholars on campus and various events that we host, including "Career Day" and a picnic reunion.
